On the way to digitisation, secure data transfer presented a challenge. Sending data encrypted is a mandatory requirement of Abrechnungszentrum Emmendingen. Emails, however, were not consistently encrypted which restricted the paths for digital transfer of data. Often when sending sensitive information other data carrying methods were used. This was expensive and time-consuming and introduced fresh risks. Additionally, certifying data protection management required higher compliance standards and controls.

A solution was necessary that not only made alternative data mediums obsolete, but also met strict compliance guidelines. SFTP was not an option as many partners did not consider it suitable and its introduction would have been very complex to manage.

A communication solution that combines security and ease of use

In its search for a communication solution, Abrechnungszentrum Emmendingen decided to put their trust in Cryptshare. Since 2011, data had been sent securely with the Web App and the API & Automation. For the decision in favour of Cryptshare in email crucial points were its simple operation integration to the company's own data centre, its high level of security and ease of use in day to day use.

For example, invoices and prescriptions that contain personal data are sent to health insurance companies securely. Additionally, it is now possible to bi-directionally communicate with customers and partners. This way health insurance companies can also submit data via the Web App, even though they have not licensed Cryptshare themselves.

Through saving time in sending data employees' efficiency has been increased and they can send files ad hoc when needed.
